As a Director General, I was responsible for the operation of the Civil Aviation Safety Investigation and Analysis Center.

### ■ Main achievements:

I set the foundation of the institution, which was inoperable and existed only formally, based on Government Ordinance no. 26/2009 regarding the establishment and functioning of the Civil Aviation Safety Investigation and Analysis Center and so I took the following measures:

- drafting and implementing the first strategy which included objectives, actions and measures for developing CASIAC for a period of 4 years (2012-2016);
- elaboration of the first operational, administrative and technical procedures regarding the accident and incident investigation in civil aviation safety and the activities which regulate the system for civil aviation occurrence reporting;
- drafting the first Investigation Manual of CASIAC;
- creating the institution website, in English and Romanian, <http://www.aias.gov.ro/index.php/en/> and the first professional training plan;
- elaborating the first Civil Aviation Safety Report (in 2012) and we continued issuing them yearly;
- defining the professional positions and duties of each employee and including them in working groups at European and international level (ICAO), in accordance with their skills and the requirements of each particular group;
- implementing, under my direct supervision, the ECCAIRS 5.4.1.25 occurrence reporting system at 6 Romanian International airports (LROP, LRCL, LRTR, LRIA, LRSA și LRCK) and at 2 Romanian air operators (TAROM and BlueAir).
- During my time as a Director General within CASIAC, from a national and international standpoint I:
- signed a cooperation protocol between CASIAC and the Prosecutor's Office attached to the High Court of Cassation and Justice, in accordance with art. 12, para. (3) of the Regulation (EU) No. 996/2010 of the European Parliament and of the Council of 20 October 2010 on the investigation and prevention of accidents and incidents in civil aviation and repealing Directive 94/56/EC;
- signed similar cooperation protocols with high level Romanian institutions and authorities (ex. ROMATSA, Romanian Civil Aeronautical Authority, Romanian Aero Club and the National Meteorology Administration);
- took all the necessary steps in order to grant CASIAC corporate membership of the International Society of Air Safety Investigators (ISASI);
- organized, in cooperation with ECAC-CEAC, the ACC/38 meeting that took place in Bucharest, Romania;
- signed a Memorandum of Understanding between CASIAC and the Interstate Aviation Committee (IAC) in Moscow regarding the investigation and prevention of accidents in civil aviation;
- signed the cooperation protocol between CASIAC and BEA France regarding cooperation and assistance in the civil aviation accident and incident investigation domain.
